Tech commentaries:

No changes to the price of **Sam Jung Pulp Co.,Ltd.** stock on the last trading day (Friday, 28th Jun 2024). During the last trading day the stock fluctuated **0.756%** from a day low at **?26,450.00** to a day high of **?26,650.00**. The price has fallen in 5 of the last 10 days and is down by **-1.3%** for this period.

The stock lies in the middle of a narrow and weak rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the stock is expected to rise **9.12%** during the next 3 months and, with a 90% probability hold a price between **?28,649.10** and **?30,073.68** at the end of this 3-month period.

A sell signal was issued from a pivot top point on **Wednesday**, **June 12**, **2024**, and so far it has fallen -1.66%. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day while price remained unchanged. This may be an early warning, but it may also not. We still recommend that you pay attention over the next couple of days. Some positive signals were issued as well, and these may have some influence on the near short-term development. The **Sam Jung Pulp Co.,Ltd.** stock holds a sell signal from the short-term Moving Average; at the same time, however, there is a buy signal from the long-term average. Since the short-term average is above the long-term average there is a general buy signal in the stock giving a positive forecast for the stock. On further gains, the stock will meet resistance from the short-term Moving Average at approximately **?26,714.29**. On a fall, the stock will find some support from the long-term average at approximately **?26,182.86**. A break-up through the short-term average will send a buy signal, whereas a breakdown through the long-term average will send a sell signal.

Sam Jung Pulp Co.,Ltd. finds support from accumulated volume at ?25,850.00 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **?26,750.00**, **?27,050.00** and **?27,100.00**.

In general the stock tends to have very controlled movements and with good liquidity the risk is considered very low in this stock. During the last day, the stock moved **?200.00** between high and low, or **0.756%**. For the last week the stock has had daily average volatility of **1.94%**.

Several of the signals/indicators are negative, and we believe that this will affect on the development for the next days and maybe possible weeks. However, over time, we think that today's level holds a possible buying opportunity and that the price will be higher during or at the end of this 3-month period.
