## Tech commentaries:

The Orient Overseas (International) Limited stock price gained 1.42\% on the last trading day (Friday, 3rd May 2024), rising from HK\$112.90 to HK $\$ 114.50$. During the last trading day the stock fluctuated $\mathbf{3 . 6 0 \%}$ from a day low at $\mathbf{H K} \$ 111.20$ to a day high of $\mathbf{H K} \$ 115.20$. The price has risen in 8 of the last 10 days and is up by $\mathbf{1 7 . 0 8 \%}$ over the past 2 weeks. Volume fell on the last day by $\mathbf{- 2 8 0}$ thousand shares and in total, $\mathbf{7 4 6}$ thousand shares were bought and sold for approximately HK $\$ 85.39$ million. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock lies the upper part of a very wide and falling trend in the short term, and this may normally pose a very good selling opportunity for the short-term trader as reaction back towards the lower part of the trend can be expected. A break up at the top trend line at HK\$115.51 will firstly indicate a slower falling rate, but may be the first sign of a trend shift. Given the current shortterm trend, the stock is expected to fall $-\mathbf{1 4 . 5 1 \%}$ during the next 3 months and, with a $90 \%$ probability hold a price between HK $\$ 73.58$ and $\mathbf{H K} \$ 98.75$ at the end of this 3-month period. Do note, that if the stock price manages to stay at current levels or higher, our prediction target will start to change positively over the next few days as the conditions for the current predictions will be broken.

Mostly positive signals in the chart today. The Orient Overseas (International) Limited stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at HK\$109.73 and HK\$106.02. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on Thursday, March 28, 2024, and so far it has risen $22.46 \%$. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely.

On the downside, the stock finds support just below today's level from accumulated volume at HK\$99.70 and HK\$96.15. On the upside the stock meets some resistance just above today's level from accumulated volume at HK\$115.40, HK\$119.20 and HK\$121.70.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved $\mathbf{H K} \$ 4.00$ between high and low, or $\mathbf{3 . 6 0 \%}$. For the last week, the stock has had daily average volatility of $3.83 \%$.

Several short-term signals are positive, despite the stock being in a falling trend, we conclude that the current level may hold a buying opportunity as there is a fair chance for stock to perform well in the short-term. We have upgraded our analysis conclusion for this stock since the last evaluation from a Hold/Accumulate to a Buy candidate.
