## **Tech commentaries:**

The Sekisui House,Ltd. stock price gained 1.27% on the last trading day (Thursday, 2nd May 2024), rising from JP¥3,621.00 to JP¥3,667.00. During the last trading day the stock fluctuated 1.83% from a day low at JP¥3,614.00 to a day high of JP¥3,680.00 . The price has risen in 6 of the last 10 days and is up by 9.43% over the past 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, 222 thousand more shares were traded than the day before. In total, 1 million shares were bought and sold for approximately JP¥5.50 billion.

The stock lies in the upper part of a weak rising trend in the short term, and this may normally pose a very good selling opportunity for the short-term trader as reaction back towards the lower part of the trend can be expected. A break-up at the top trend line at JP¥3,669.75 will firstly indicate a stronger rate of rising. Given the current short-term trend, the stock is expected to rise 9.35% during the next 3 months and, with a 90% probability hold a price between JP¥3,709.69 and JP¥4,012.81 at the end of this 3-month period.

The Sekisui House, Ltd. stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at JP¥3,590.57 and JP¥3,475.31. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on Friday, April 19, 2024, and so far it has risen 9.46%. Further rise is indicated until a new top pivot has been found. Volume is rising along with the price. This is considered to be a good technical signal. Some negative signals were issued as well, and these may have some influence on the near short-term development. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD).

On the downside, the stock finds support just below today's level from accumulated volume at JP¥3,473.00 and JP¥3,434.00. There is no resistance from accumulated volume above today's level and given the right condition the stock may perform very well during the next couple of days.

This stock is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the stock moved JP¥66.00 (1.83%) between high and low. For the last week, the stock has had daily average volatility of 1.79%.

Several short-term signals, along with a general good trend, are positive and we conclude that the current level may hold a buying opportunity as there is a fair chance for **Sekisui House,Ltd.** stock to perform well in the short-term.
