Tech commentaries:

The **EuBiologics Co., Ltd.** stock price gained **0.628%** on the last trading day (Friday, 17th May 2024), rising from **12,730.00** to **12,810.00**. During the last trading day the stock fluctuated **5.65%** from a day low of **12,380.00** to a day high of **13,080.00**. The price has fallen in 6 of the last 10 days and is down by **-4.33%** for this period. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, **45 thousand** more shares were traded than the day before. In total, **233 thousand** shares were bought and sold for approximately **2.98 billion**.

The stock lies in the lower part of a wide and weak rising trend in the short term, and this may normally pose a very good buying opportunity. If the lower trend floor at **12,743.62** is broken, it will firstly indicate a slower rate of rising, but may also be an early warning for a trend shift. Given the current short-term trend, the stock is expected to rise **9.27%** during the next 3 months and, with a 90% probability hold a price between **13,924.76** and **15,661.14** at the end of this 3-month period.

Volume is rising along with the price. This is considered to be a good technical signal. Some negative signals were issued as well, and these may have some influence on the near short-term development. The **EuBiologics Co., Ltd.** stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. On corrections up, there will be some resistance from the lines at **12,950.00** and **12,832.29**. A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on **Friday, April 26, 2024**, and so far it has fallen **-7.91%**. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD).

EuBiologics Co., Ltd. finds support from accumulated volume at **12,700.00** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **12,930.00**, **13,550.00** and **13,900.00**.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved **700.00** between high and low, or **5.65%**. For the last week, the stock has had daily average volatility of **3.56%**.

The **EuBiologics Co., Ltd.** stock holds several negative signals and despite the positive trend, we believe **EuBiologics Co., Ltd.** will perform weakly in the next couple of days or weeks. Therefore, we hold a negative evaluation of this stock.
