
Regina Miracle International (Holdings) Limited (Fri, May 17, 2024)

Tech commentaries:

The Regina Miracle International (Holdings) stock price fell by -5.84% on the last day (Friday, 17th May 2024) from HK\$2.91 to HK\$2.74. It has now fallen 3 days in a row. During the last trading day the stock fluctuated 8.78% from a day low at HK\$2.62 to a day high of HK\$2.85. The price has risen in 7 of the last 10 days and is up by 22.87% over the past 2 weeks. Volume has increased on the last day by 271 thousand shares but on falling prices. This may be an early warning and the risk will be increased slightly over the next couple of days. In total, 311 thousand shares were bought and sold for approximately HK\$852.14 thousand.

The stock lies in the middle of a very wide and strong rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the stock is expected to rise 32.47% during the next 3 months and, with a 90% probability hold a price between HK\$3.04 and HK\$3.96 at the end of this 3-month period.

The Regina Miracle International (Holdings) stock holds a sell signal from the short-term Moving Average; at the same time, however, there is a buy signal from the long-term average. Since the short-term average is above the long-term average there is a general buy signal in the stock giving a positive forecast for the stock. On further gains, the stock will meet resistance from the short-term Moving Average at approximately HK\$2.82. On a fall, the stock will find some support from the long-term average at approximately HK\$2.31. A break-up through the short-term average will send a buy signal, whereas a breakdown through the long-term average will send a sell signal. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on Monday, May 13, 2024, and so far it has fallen -7.12%. Further fall is indicated until a new bottom pivot has been found. Regina Miracle International (Holdings) gained volume on the last day, but on falling prices. In technical terms, this is called divergence and may be an early warning. In some cases, increasing volume on falling prices may be considered positive, but that is mainly in typical "sell-offs".

On the downside, the stock finds support just below today's level from accumulated volume at HK\$2.30 and HK\$2.29. On the upside the stock meets some resistance just above today's level from accumulated volume at HK\$2.76, HK\$2.93 and HK\$2.95.

This stock may move much during the day (volatility) and with a large prediction interval from the Bollinger Band this stock is considered to be "high risk". During the last day, the stock moved HK\$0.230 between high and low, or 8.78%. For the last week, the stock has had daily average volatility of 5.93%.

Regina Miracle International (Holdings) holds several positive signals, but we still don't find these to be enough for a buy candidate. At the current level, it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development. Due to some small weaknesses in the technical picture we have downgraded our analysis conclusion for this stock since the last evaluation from a Buy to a Hold/Accumulate candidate.
