

Tech commentaries:

The **Rego Interactive Co.**, **Ltd** stock price gained **3.85%** on the last trading day (Friday, 28th Jun 2024), rising from **HK\$0.390** to **HK\$0.405**. During the last trading day the stock fluctuated **5.19%** from a day low at **HK\$0.385** to a day high of **HK\$0.405**. The price has risen in 6 of the last 10 days. Volume fell on the last day by **-488 thousand** shares and in total, **84** thousand shares were bought and sold for approximately **HK\$34.02** thousand. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock is moving within a very wide and horizontal trend and further movements within this trend can be expected. Given the current horizontal trend, you can expect **Rego Interactive Co., Ltd** stock with a 90% probability to be traded between HK\$0.367 and HK\$0.459 at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and stocks seldom manage to go directly from the bottom of a trend up to the top. Stocks turning up in the middle of a horizontal trend are therefore considered to be potential runners.

The **Rego Interactive Co., Ltd** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock, but the stock has a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections down, there will be some support from the lines at **HK\$0.391** and **HK\$0.403**. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on **Friday, June 21, 2024**, and so far it has risen 8.00%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. Volume fell during the last trading day while the price increased. This causes a divergence and may be considered as an early warning, but it may not be. The very low volume increases the risk and reduces the other technical signals issued.

Rego Interactive Co., Ltd finds support from accumulated volume at HK\$0.395 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **HK\$0.410**, **HK\$0.420** and **HK\$0.470**.

This stock has average movements during the day, but be aware of low or falling volume as this increases the risk. During the last day, the stock moved **HK\$0.0200** between high and low, or **5.19%**. For the last week the stock has had daily average volatility of **7.65%**.

Several short-term signals are positive and we conclude that the current level may hold a buying opportunity, as there is a fair chance for **Rego Interactive Co.**, **Ltd** stock to perform well in the short-term period. We have upgraded our analysis conclusion for this stock since the last evaluation from a Hold/Accumulate to a Buy candidate.
