During the last trading day the stock fluctuated **0.95%** from a day low at **?3,675.00** to a day high of **?3,710.00**. The price has risen in 7 of the last 10 days and is up by **3.8%** over the past 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, **42 thousand** more shares were traded than the day before. In total, **59** thousand shares were bought and sold for approximately **?217.50** million.

The stock lies in the middle of a weak rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the stock is expected to rise **6.48%** during the next 3 months and, with a 90% probability hold a price between **?3,748.40** and **?4,121.29** at the end of this 3-month period.

The **KB** Asset Management Co., Ltd. - KB stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock, but the stock has a general sell signal from the relation between the two signals where the long-term average is above the short-term average.
