

Tech commentaries:

The SUMCO CORPORATION stock price fell by -0.529% on the last day (Monday, 27th May 2024) from JP¥2,362.50 to JP¥2,350.00. During the last trading day the stock fluctuated 1.29% from a day low at JP¥2,334.50 to a day high of JP¥2,364.50 . The price has fallen in 7 of the last 10 days and is down by -7.26% for this period. Volume fell on the last day along with the stock, which is actually a good sign as volume should follow the stock. On the last day, the trading volume fell by -2 million shares and in total, 3 million shares were bought and sold for approximately JP¥7.67 billion.

The stock is at the lower part of a wide and horizontal trend in the short term, and normally this may pose a good buying opportunity, though a breakdown through the bottom trend line at JP¥2,279.78 will give a strong sell signal and a trend shift may be expected. Given the current horizontal trend, you can expect SUMCO CORPORATION stock with a 90% probability to be traded between JP¥2,280.54 and JP¥2,649.28 at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and stocks seldom manage to go directly from the bottom of a trend up to the top. Stocks turning up in the middle of a horizontal trend are therefore considered to be potential runners.

Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. The SUMCO CORPORATION stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at JP¥2,412.36 and JP¥2,460.46. A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on Friday, May 10, 2024, and so far it has fallen -9.30%. Further fall is indicated until a new bottom pivot has been found. Volume fell together with the price during the last trading day and this reduces the overall risk as volume should follow the price movements.

SUMCO CORPORATION finds support from accumulated volume at JP¥2,340.50 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at JP¥2,361.50, JP¥2,500.00 and JP¥2,591.00.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved JP¥30.00 between high and low, or 1.29%. For the last week, the stock has had daily average volatility of 2.22%.

SUMCO CORPORATION holds several negative signals and this should be a sell candidate, but due to the general chance for a turnaround situation it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development.
