

Tech commentaries:

The ZIGExN Co., Ltd. stock price gained 0.668% on the last trading day (Wednesday, 26th Jun 2024), rising from JP¥599.00 to JP¥603.00. During the last trading day the stock fluctuated 1.85% from a day low at JP¥593.00 to a day high of JP¥604.00. The price has fallen in 5 of the last 10 days and is down by -4.89% for this period. Volume fell on the last day by -39 thousand shares and in total, 242 thousand shares were bought and sold for approximately JP¥145.62 million. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock lies in the middle of a very wide and weak rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the stock is expected to rise 10.00% during the next 3 months and, with a 90% probability hold a price between JP¥611.37 and JP¥766.35 at the end of this 3-month period.

Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely. Some negative signals were issued as well, and these may have some influence on the near short-term development. The ZIGExN Co.,Ltd. stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at JP¥605.14 and JP¥623.23. A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on Monday, May 13, 2024, and so far it has fallen -9.19%. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD).

On the downside, the stock finds support just below today's level from accumulated volume at JP¥553.00 and JP¥552.00. On the upside the stock meets some resistance just above today's level from accumulated volume at JP¥624.00, JP¥652.00 and JP¥664.00.

This stock is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the stock moved JP¥11.00 (1.85%) between high and low. For the last week, the stock has had daily average volatility of 2.58%.

The ZIGExN Co.,Ltd. stock holds several negative signals and despite the positive trend, we believe ZIGExN Co.,Ltd. will perform weakly in the next couple of days or weeks. Therefore, we hold a negative evaluation of this stock.
