

## **Tech commentaries:**

The **Kiddieland International Limited** stock price fell by **-14.29%** on the last day (Friday, 17th May 2024) from **HK\$0.0420** to **HK\$0.0360**. During the last trading day the stock fluctuated **2.86%** from a day low at **HK\$0.0350** to a day high of **HK\$0.0360**. The price has been going up and down for this period, and there has been a 16.13% gain for the last 2 weeks. Volume has increased on the last day by **35 thousand** shares but on falling prices. This may be an early warning and the risk will be increased slightly over the next couple of days. In total, **100** thousand shares were bought and sold for approximately **HK\$3.60** thousand.

The stock lies in the middle of a very wide and falling trend in the short term and further fall within the trend is signaled. Given the current short-term trend, the stock is expected to fall **-15.97%** during the next 3 months and, with a 90% probability hold a price between **HK\$0.0214** and **HK\$0.0352** at the end of this 3-month period. Do note, that if the stock price manages to stay at current levels or higher, our prediction target will start to change positively over the next few days as the conditions for the current predictions will be broken.

The **Kiddieland International Limited** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **HK\$0.0357** and **HK\$0.0335**. A breakdown below any of these levels will issue sell signals. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on **Thursday, May 16, 2024**, and so far it has fallen - 14.29%. Further fall is indicated until a new bottom pivot has been found. **Kiddieland International Limited** gained volume on the last day, but on falling prices. In technical terms, this is called divergence and may be an early warning. In some cases, increasing volume on falling prices may be considered positive, but that is mainly in typical "sell-offs". The very low volume increases the risk and reduces the other technical signals issued.

**Kiddieland International Limited** finds support from accumulated volume at HK\$0.0350 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **HK\$0.0370**, **HK\$0.0380** and **HK\$0.0420**.

This stock may move very much during the day (volatility) and with a very large prediction interval from the Bollinger Band this stock is considered to be "very high risk". During the last day, the stock moved **HK\$0.0010** between high and low, or **2.86%**. For the last week, the stock has had daily average volatility of **8.36%**.

**Kiddieland International Limited** holds several positive signals, but we still don't find these to be enough for a buy candidate. At the current level, it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development.
