Tech commentaries:

The **Suzhou Iron Technology CO.,LTD.** stock price gained **1.16%** on the last trading day (Friday, 28th Jun 2024), rising from **\$14.69** to **\$14.86**. During the last trading day the stock fluctuated **3.13%** from a day low at **\$14.69** to a day high of **\$15.15**. The price has been going up and down for this period, and there has been a **-3.13%** loss for the last 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, **126 thousand** more shares were traded than the day before. In total, **511 thousand** shares were bought and sold for approximately **\$7.60** million.

The stock lies in the middle of a wide and falling trend in the short term and further fall within the trend is signaled. Given the current short-term trend, the stock is expected to fall **-22.06%** during the next 3 months and, with a 90% probability hold a price between **\$10.89** and **\$13.61** at the end of this 3-month period. Do note, that if the stock price manages to stay at current levels or higher, our prediction target will start to change positively over the next few days as the conditions for the current predictions will be broken.

There are mixed signals in the stock today. The **Suzhou Iron Technology CO.,LTD.** stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at **\$14.91** and **\$16.15**. A break-up above any of these levels will issue buy signals. A buy signal was issued from a pivot bottom point on **Monday, June 24, 2024**, and so far it has risen 3.84%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume is rising along with the price. This is considered to be a good technical signal.

Suzhou Iron Technology CO.,LTD. finds support from accumulated volume at **\$14.57** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance from accumulated volume at **\$17.69**, **\$17.81** and **\$18.04**.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved **\$0.460** between high and low, or **3.13%**. For the last week, the stock has had daily average volatility of **4.81%**.

Suzhou Iron Technology CO.,LTD. holds several negative signals and we believe that it will still perform weakly in the next couple of days or weeks. We, therefore, hold a negative evaluation of this stock.
