

## **Tech commentaries:**

The Sompo Holdings,Inc. stock price gained 0.721% on the last trading day (Thursday, 9th May 2024), rising from JP¥3,050.00 to JP¥3,072.00. During the last trading day the stock fluctuated 0.95% from a day low at JP¥3,056.00 to a day high of JP¥3,085.00. The price has risen in 7 of the last 10 days and is up by 1.09% over the past 2 weeks. Volume fell on the last day by -348 thousand shares and in total, 2 million shares were bought and sold for approximately JP¥5.63 billion. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock lies in the middle of a very wide and falling trend in the short term and further fall within the trend is signaled. Due to the high volatility and the trend direction we are not able to give forecast range for this stock. Do note, that if the stock price manages to stay at current levels or higher, our prediction target will start to change positively over the next few days as the conditions for the current predictions will be broken.

A buy signal was issued from a pivot bottom point on **Monday, April 01, 2024**, and so far it has risen 1.82%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely. Some negative signals were issued as well, and these may have some influence on the near short-term development. The **Sompo Holdings,Inc.** stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at **JP¥3,088.43** and **JP¥4,387.46**. A break-up above any of these levels will issue buy signals.

**Sompo Holdings,Inc.** finds support from accumulated volume at JP¥3,050.00 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at JP¥3,080.00, JP¥3,120.00 and JP¥3,190.00.

This stock is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the stock moved **JP¥29.00 (0.95%)** between high and low. For the last week, the stock has had daily average volatility of **1.70%**.

**Sompo Holdings,Inc.** holds several negative signals and is within a very wide and falling trend, so we believe it will still perform weakly in the next couple of days or weeks. We therefore hold a negative evaluation of this stock.
