
Xtrackers Harvest Ftse China A-h 50 Ucits Etf (Fri, Jun 28, 2024)

Tech commentaries:

The Xtrackers Harvest Ftse China A-h 50 ETF price fell by -0.0223% on the last day (Friday, 28th Jun 2024) from 22.47€to 22.46€ During the last trading day the ETF fluctuated 0.445% from a day low at 22.46€to a day high of 22.56€ The price has been going up and down for this period, and there has been a -1.17% loss for the last 2 weeks. Volume fell on the last day along with the ETF, which is actually a good sign as volume should follow the ETF. On the last day, the trading volume fell by -369 shares and in total, 47 shares were bought and sold for approximately 1.06€thousand.

The ETF has broken the weak rising short-term trend down. This signalizes a slower rate of rising, but may also be an early warning about a possible trend shift. Due to the trend being broken there will now be resistance at the bottom line of the trend at 22.61€ A reaction back to this level may hold a second chance to get out before further falls.

There are mixed signals in the ETF today. The **Xtrackers Harvest Ftse China A-h 50** ETF holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at **22.68**€ and **23.09**€ A break-up above any of these levels will issue buy signals. Volume fell along with the price during the last trading day which is technical positive. One should, however, note that this ETF may have low liquidity in periods, which increases the general risk. The very low volume increases the risk and reduces the other technical signals issued. A buy signal was issued from a pivot bottom point on **Thursday, June 13, 2024**, and so far it has risen 0.0223%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD).

Xtrackers Harvest Ftse China A-h 50 finds support from accumulated volume at 22.34€ and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the ETF meets some resistance just above today's level from accumulated volume at **22.63€ 22.63€** and **22.90€**

In general the ETF tends to have very controlled movements and therefore the general risk is considered very low. However, be aware of low or falling volume and make sure to keep an eye on the ETF During the last day, the ETF moved 0.1000€ between high and low, or 0.445%. For the last week the ETF has had daily average volatility of 0.81%

Xtrackers Harvest Ftse China A-h 50 holds several negative signals and we believe that it will still perform weakly in the next couple of days or weeks. We, therefore, hold a negative evaluation of this ETF. Due to some small weaknesses in the technical picture we have downgraded our analysis conclusion for this ETF since the last evaluation from a Hold/Accumulate to a Sell candidate.
