
Avio S.p.A. (Tue, Jul 02, 2024)

Tech commentaries:

The Avio S.p.A. stock price gained 0.98% on the last trading day (Tuesday, 2nd Jul 2024), rising from 12.20€ to 12.32€ During the last trading day the stock fluctuated 2.31% from a day low at 12.10€to a day high of 12.38€ The price has been going up and down for this period, and there has been a 3.88% gain for the last 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, 10 thousand more shares were traded than the day before. In total, 50 thousand shares were bought and sold for approximately 612.58€thousand.

The stock lies in the middle of a wide and strong rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the stock is expected to rise 16.94% during the next 3 months and, with a 90% probability hold a price between 13.65€ and 15.48€ at the end of this 3-month period.

Mostly positive signals in the chart today. The Avio S.p.A. stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at 12.08€ and 11.79€ A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on Tuesday, June 11, 2024, and so far it has risen 9.80%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Avio S.p.A. has increased volume and follows the last lift in the price. This is considered to be a technical positive sign as volume should follow the price-formation. Higher liquidity also reduces the general risk.

Avio S.p.A. finds support from accumulated volume at 12.08€ and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. There is no resistance from accumulated volume above today's level and given the right condition the stock may perform very well during the next couple of days.

This stock is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the stock moved 0.280€ (2.31%) between high and low. For the last week, the stock has had daily average volatility of 2.96%.

Avio S.p.A. holds several positive signals and is within a strong rising trend. As the old saying says, "Let the trend be your friend."". We therefore consider it to be a good choice at these current levels and we are expecting further gains during the next 3 months. We have upgraded our analysis conclusion for this stock since the last evaluation from a Buy to a Strong Buy candidate.
