Tech commentaries:

The **Invesco Bulletshares 2030 Municipal Bond** ETF price fell by **-0.0914%** on the last day (Tuesday, 25th Jun 2024) from **\$21.88** to **\$21.86**. It has now fallen 4 days in a row. During the last trading day the ETF fluctuated **0.137%** from a day low at **\$21.86** to a day high of **\$21.89**. The price has been going up and down for this period, and there has been a 0.43% gain for the last 2 weeks. Volume has increased on the last day by **8 thousand** shares but on falling prices. This may be an early warning and the risk will be increased slightly over the next couple of days. In total, **17 thousand** shares were bought and sold for approximately **\$369.72** thousand.

The ETF is moving within a narrow and horizontal trend and further movements within this trend can be expected. Given the current horizontal trend, you can expect **Invesco Bulletshares 2030 Municipal Bond** ETF with a 90% probability to be traded between **\$21.32** and **\$21.80** at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and ETFs seldom manage to go directly from the bottom of a trend up to the top. ETFs turning up in the middle of a horizontal trend are therefore considered to be potential runners. Do note, that if the stock price manages to stay at current levels or higher, our prediction target will start to change positively over the next few days as the conditions for the current predictions will be broken.

The **Invesco Bulletshares 2030 Municipal Bond** ETF holds a sell signal from the short-term Moving Average; at the same time, however, there is a buy signal from the long-term average. Since the short-term average is above the long-term average there is a general buy signal in the ETF giving a positive forecast for the stock. On further gains, the ETF will meet resistance from the short-term Moving Average at approximately **\$21.92**. On a fall, the ETF will find some support from the long-term average at approximately **\$21.83**. A break-up through the short-term average will send a buy signal, whereas a breakdown through the long-term average will send a sell signal. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on **Friday, June 14, 2024**, and so far it has fallen - 0.548%. Further fall is indicated until a new bottom pivot has been found. **Invesco Bulletshares 2030 Municipal Bond** gained volume on the last day, but on falling prices. In technical terms, this is called divergence and may be an early warning. In some cases, increasing volume on falling prices may be considered positive, but that is mainly in typical "sell-offs".

Invesco Bulletshares 2030 Municipal Bond finds support from accumulated volume at **\$21.85** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the ETF meets some resistance just above today's level from accumulated volume at **\$21.96**, **\$21.97** and **\$21.99**.

In general the ETF tends to have very controlled movements and with good liquidity the risk is considered very low in this stock. During the last day, the ETF moved **\$0.0300** between high and low, or **0.137%**. For the last week the ETF has had daily average volatility of **0.230%**.

Invesco Bulletshares 2030 Municipal Bond holds several negative signals and we believe that it will still perform weakly in the next couple of days or weeks. We, therefore, hold a negative evaluation of this ETF. Due to some small weaknesses in the
