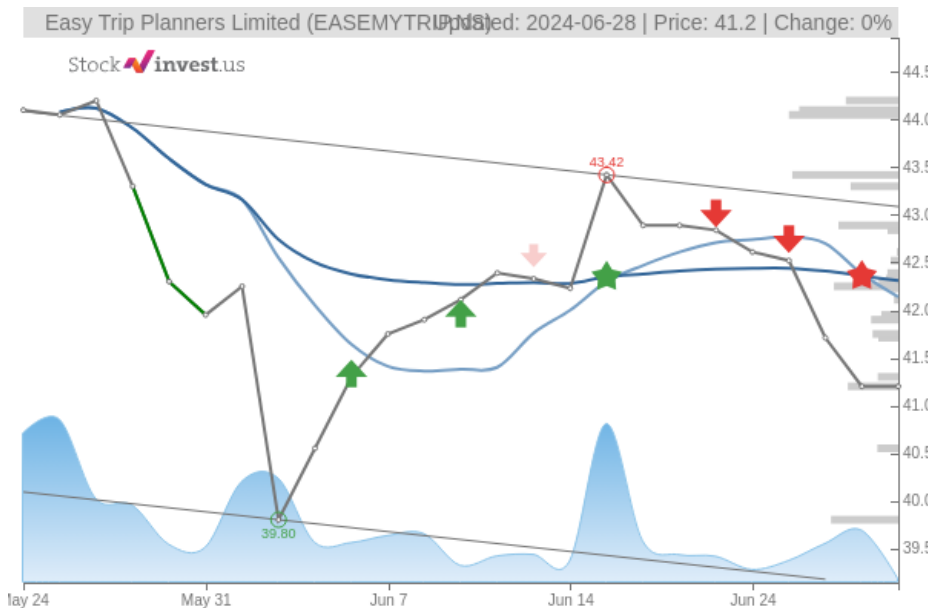

Tech commentaries:

No changes to the price of **Easy Trip Planners Limited** stock on the last trading day (Friday, 28th Jun 2024). During the last trading day the stock fluctuated **1.32%** from a day low at **41.05** to a day high of **41.59**. The price has fallen in 7 of the last 10 days and is down by **-2.67%** for this period.

The stock lies in the middle of a wide and falling trend in the short term and further fall within the trend is signaled. Given the current short-term trend, the stock is expected to fall **-2.27%** during the next 3 months and, with a 90% probability hold a price between **38.21** and **42.11** at the end of this 3-month period.

Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. The **Easy Trip Planners Limited** stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at **42.14** and **42.31**. A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on **Tuesday, June 18, 2024**, and so far it has fallen **-5.11%**. Further fall is indicated until a new bottom pivot has been found. Volume fell during the last trading day while price remained unchanged. This may be an early warning, but it may also not. We still recommend that you pay attention over the next couple of days.

Easy Trip Planners Limited finds support from accumulated volume at **40.55** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance from accumulated volume at **43.42**, **44.05** and **44.10**.

This stock is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the stock moved **0.540 (1.32%)** between high and low. For the last week, the stock has had daily average volatility of **1.92%**.

Easy Trip Planners Limited holds several negative signals and is within a wide and falling trend, so we believe it will still perform weakly in the next couple of days or weeks. We therefore hold a negative evaluation of this stock.
