Tech commentaries:

The Goodyear Lastikleri T.A.S. stock price fell by -0.182% on the last day (Friday, 3rd May 2024) from TRY 21.94 to TRY 21.90. During the last trading day the stock fluctuated 1.93% from a day low at TRY 21.80 to a day high of TRY 22.22. The price has risen in 7 of the last 10 days and is up by 11% over the past 2 weeks. Volume fell on the last day along with the stock, which is actually a good sign as volume should follow the stock. On the last day, the trading volume fell by -2 million shares and in total, 1 million shares were bought and sold for approximately TRY 23.70 million.

The stock lies in the middle of a very wide and falling trend in the short term and further fall within the trend is signaled. Given the current short-term trend, the stock is expected to fall **-10.05%** during the next 3 months and, with a 90% probability hold a price between **TRY 16.18** and **TRY 21.19** at the end of this 3-month period. Do note, that if the stock price manages to stay at current levels or higher, our prediction target will start to change positively over the next few days as the conditions for the current predictions will be broken.

The **Goodyear Lastikleri T.A.S.** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **TRY 21.49** and **TRY 21.25**. A breakdown below any of these levels will issue sell signals. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on **Thursday, May 02, 2024**, and so far it has fallen - 0.182%. Further fall is indicated until a new bottom pivot has been found. Volume fell together with the price during the last trading day and this reduces the overall risk as volume should follow the price movements.

Goodyear Lastikleri T.A.S. finds support from accumulated volume at TRY 21.80 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance from accumulated volume at TRY 23.72, TRY 23.96 and TRY 24.76.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved **TRY 0.420** between high and low, or **1.93%**. For the last week, the stock has had daily average volatility of **3.00%**.

Several short-term signals are positive, despite the stock being in a falling trend, we conclude that the current level may hold a buying opportunity as there is a fair chance for stock to perform well in the short-term.
