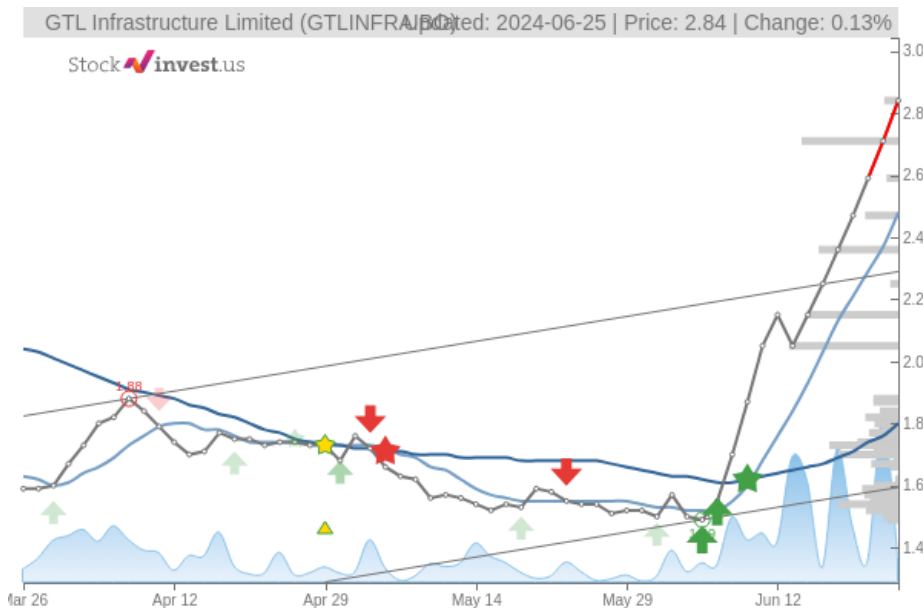

Tech commentaries:

The **GTL Infrastructure Limited** stock price gained **4.80%** on the last trading day (Tuesday, 25th Jun 2024), rising from **22.71** to **22.84**. It has now gained 7 days in a row. It is not often that stocks manage to gain so many days in a row, and falls for a day or two should be expected. During the last trading day the stock fluctuated **2.90%** from a day low at **22.76** to a day high of **22.84**. The price has risen in 9 of the last 10 days and is up by **51.87%** over the past 2 weeks. Volume fell on the last day by **-139 million** shares and in total, **35 million** shares were bought and sold for approximately **299.65 million**. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock has broken the very wide and strong rising the short-term trend up and an even stronger rate of rising is indicated. For any reaction back there will now be support on the roof on the current trend broken at **22.29**, a level that may pose a second chance to hit a runner. According to fan-theory **22.98** will be the next possible trend-top level and thereby pose a resistance level that may not be broken at the first attempt.

The **GTL Infrastructure Limited** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **22.48** and **21.80**. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on **Wednesday, June 05, 2024**, and so far it has risen 90.60%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely.

GTL Infrastructure Limited finds support from accumulated volume at **22.71** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. There is no resistance from accumulated volume above today's level and given the right condition the stock may perform very well during the next couple of days.

This stock may move very much during the day (volatility) and with a very large prediction interval from the Bollinger Band this stock is considered to be "very high risk". During the last day, the stock moved **0.0800** between high and low, or **2.90%**. For the last week, the stock has had daily average volatility of **4.00%**.

GTL Infrastructure Limited holds several positive signals, but we still don't find these to be enough for a buy candidate. At the current level, it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development.
