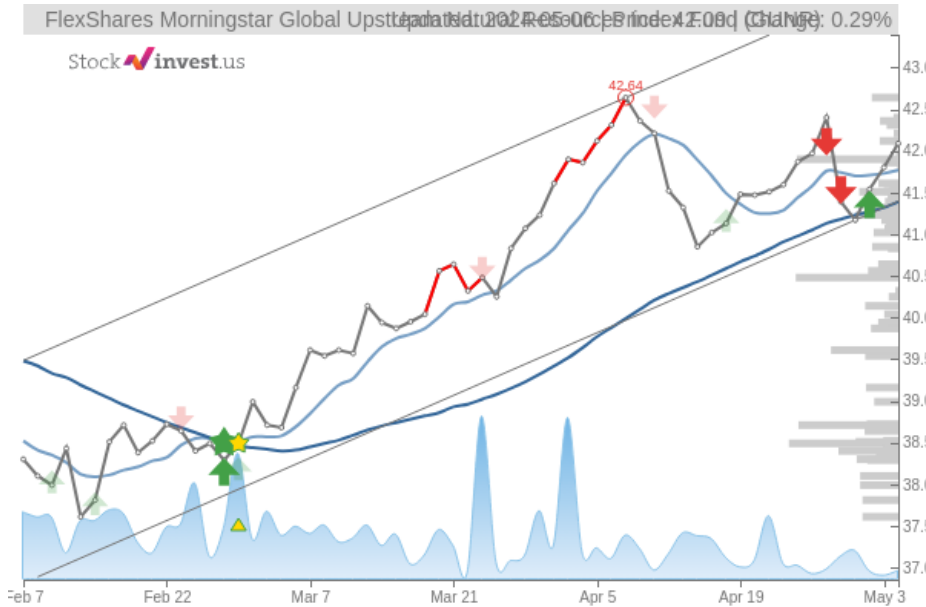


FlexShares Morningstar Global Upstream Natural Resources Index Fund

Tech commentaries:

The **FlexShares Morningstar Global Upstream** ETF price gained **0.694%** on the last trading day (Monday, 6th May 2024), rising from **\$41.80** to **\$42.09**. It has now gained 3 days in a row. It will be exciting to see whether it manages to continue gaining or take a minor break for the next few days. During the last trading day the ETF fluctuated **0.429%** from a day low at **\$41.99** to a day high of **\$42.17**. The price has risen in 8 of the last 10 days and is up by **1.5%** over the past 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, **45 thousand** more shares were traded than the day before. In total, **314 thousand** shares were bought and sold for approximately **\$13.22 million**.

The ETF lies in the middle of a strong rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the ETF is expected to rise **11.61%** during the next 3 months and, with a 90% probability hold a price between **\$46.20** and **\$49.18** at the end of this 3-month period.

The **FlexShares Morningstar Global Upstream** ETF holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **\$41.77** and **\$41.39**. A breakdown below any of these levels will issue sell signals. Volume is rising along with the price. This is considered to be a good technical signal. Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on **Tuesday, April 09, 2024**, and so far it has fallen **-1.29%**. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD).

FlexShares Morningstar Global Upstream finds support from accumulated volume at **\$41.90** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the ETF meets some resistance just above today's level from accumulated volume at **\$42.12**, **\$42.36** and **\$42.64**.

In general the ETF tends to have very controlled movements and with good liquidity the risk is considered very low in this stock. During the last day, the ETF moved **\$0.180** between high and low, or **0.429%**. For the last week the ETF has had daily average volatility of **1.09%**.

Several short-term signals, along with a general good trend, are positive and we conclude that the current level may hold a buying opportunity as there is a fair chance for **FlexShares Morningstar Global Upstream** ETF to perform well in the short-term.
