


Tech commentaries:

The Halder Venture Limited stock price gained 1.74% on the last trading day (Tuesday, 25th Jun 2024), rising from ?689.00 to ?701.00. It has now gained 5 days in a row. It will be exciting to see whether it manages to continue gaining or take a minor break for the next few days. During the last trading day the stock fluctuated 2.49% from a day low at ?684.15 to a day high of ?701.20. The price has risen in 8 of the last 10 days and is up by 10.39% over the past 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, 89 more shares were traded than the day before. In total, 3 thousand shares were bought and sold for approximately ?1.82 million.

The stock has broken the wide and strong rising short-term trend down. This signalizes a slower rate of rising, but may also be an early warning about a possible trend shift. Due to the trend being broken there will now be resistance at the bottom line of the trend at **?704.85**. A reaction back to this level may hold a second chance to get out before further falls.

The **Halder Venture Limited** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **?669.33** and **?590.21**. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on **Friday, May 10, 2024**, and so far it has risen 36.93%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume is rising along with the price. This is considered to be a good technical signal.

On the downside, the stock finds support just below today's level from accumulated volume at **?567.95** and **?541.05**. There is no resistance from accumulated volume above today's level and given the right condition the stock may perform very well during the next couple of days.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved **?17.05** between high and low, or **2.49%**. For the last week, the stock has had daily average volatility of **0.96%**.

Halder Venture Limited holds several positive signals, but we still don't find these to be enough for a buy candidate. At the current level, it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development.
