

Tech commentaries:

No changes to the price of **Ishares Global Water Ucits Etf Usd** ETF on the last trading day (Thursday, 27th Jun 2024). During the last trading day the ETF fluctuated **0**% from a day low at £5,161.00 to a day high of £5,161.00. The price has fallen in 5 of the last 10 days and is down by **-0.83**% for this period.

The ETF lies in the lower part of a weak rising trend in the short term, and this may normally pose a very good buying opportunity. If the lower trend floor at £5,105.96 is broken, it will firstly indicate a slower rate of rising, but may also be an early warning for a trend shift. Given the current short-term trend, the ETF is expected to rise **2.33%** during the next 3 months and, with a 90% probability hold a price between £5,225.01 and £5,719.77 at the end of this 3-month period.

There are mixed signals in the ETF today. The **Ishares Global Water Ucits Etf Usd** ETF holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at £5,187.00 and £5,304.89. A break-up above any of these levels will issue buy signals. Volume fell on the last day without any changes to the price. This does not cause any direct divergence but may be an early warning and a possible "turning point". The very low volume increases the risk and reduces the other technical signals issued. A buy signal was issued from a pivot bottom point on **Tuesday, June 11, 2024**, and so far it has risen 0.428%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD).

Ishares Global Water Ucits Etf Usd finds support from accumulated volume at £5,139.00 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the ETF meets some resistance just above today's level from accumulated volume at £5,202.00, £5,425.00 and £5,481.00.

In general the ETF tends to have very controlled movements and therefore the general risk is considered very low. However, be aware of low or falling volume and make sure to keep an eye on the ETF During the last day, the ETF moved £0 between high and low, or 0%. For the last week the ETF has had daily average volatility of 0.798%

Several short-term signals, along with a general good trend, are positive and we conclude that the current level may hold a buying opportunity as there is a fair chance for **Ishares Global Water Ucits Etf Usd** ETF to perform well in the short-term. We have upgraded our analysis conclusion for this ETF since the last evaluation from a Hold/Accumulate to a Buy candidate.
