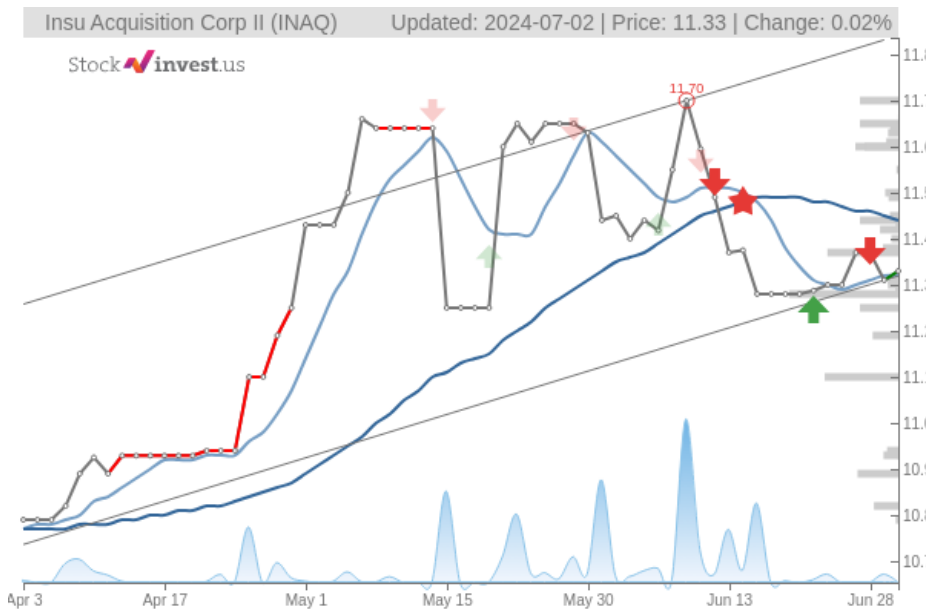


# Insu Acquisition Corp II (Tue, Jul 02, 2024)

## Tech commentaries:

The **Insu Acquisition Corp II** stock price gained **0.177%** on the last trading day (Tuesday, 2nd Jul 2024), rising from **\$11.31** to **\$11.33**. During the last trading day the stock fluctuated **0.265%** from a day low at **\$11.30** to a day high of **\$11.33**. The price has been going up and down for this period, and there has been a 0.44% gain for the last 2 weeks. Volume fell on the last day by **-4 thousand** shares and in total, **522** shares were bought and sold for approximately **\$5.91** thousand. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock lies in the lower part of a narrow and weak rising trend in the short term, and this may normally pose a very good buying opportunity. If the lower trend floor at \$11.32 is broken, it will firstly indicate a slower rate of rising, but may also be an early warning for a trend shift. Given the current short-term trend, the stock is expected to rise **5.18%** during the next 3 months and, with a 90% probability hold a price between **\$11.91** and **\$12.45** at the end of this 3-month period.

There are few to no technical positive signals at the moment. The **Insu Acquisition Corp II** stock holds a buy signal from the short-term Moving Average; at the same time, however, the long-term average holds a general sell signal. Since the long-term average is above the short-term average there is a general sell signal in the stock giving a more negative forecast for the stock. On further gains, the stock will meet resistance from the long-term Moving Average at **\$11.44**. On a fall, the stock will find some support from the short-term average at **\$11.32**. A break-up through the long-term average will give another buy signal, while a fall below the short-term average will add another sell signal and strengthen the general signal. A sell signal was issued from a pivot top point on **Monday, June 10, 2024**, and so far it has fallen -3.16%. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day while the price increased. This causes a divergence and may be considered as an early warning, but it may not be. The very low volume increases the risk and reduces the other technical signals issued.

**Insu Acquisition Corp II** finds support from accumulated volume at \$11.28 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **\$11.44**, **\$11.65** and **\$11.70**.

In general the stock tends to have very controlled movements and therefore the general risk is considered very low. However, be aware of low or falling volume and make sure to keep an eye on the stock During the last day, the stock moved **\$0.0300** between high and low, or **0.265%**. For the last week the stock has had daily average volatility of **0.106%**

**Insu Acquisition Corp II** holds several negative signals and this should be a sell candidate, but due to the general chance for a turnaround situation it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development.
