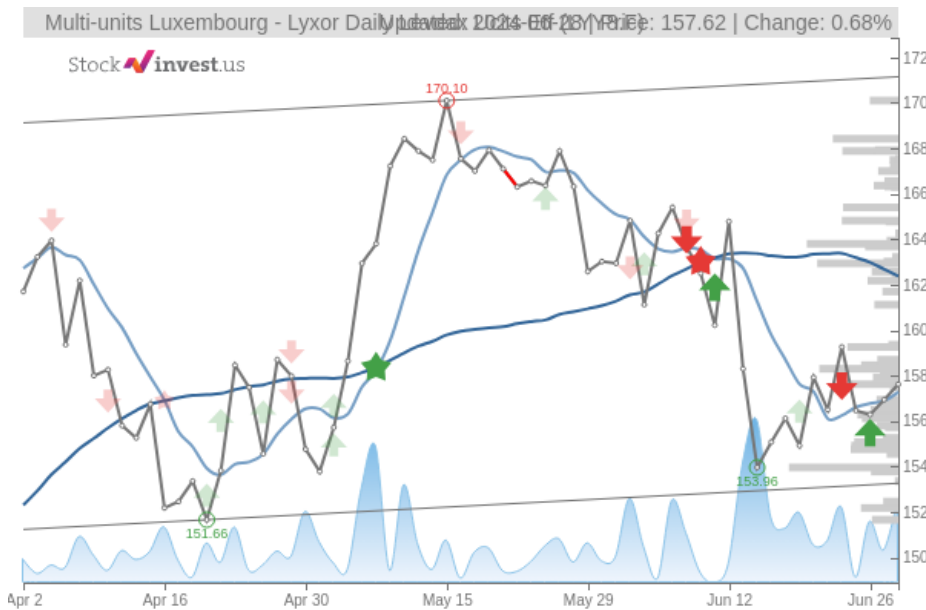


Multi-units Luxembourg - Lyxor Daily Lev dax Ucits Etf (Fri, Jun 28, 2024)

Tech commentaries:

The **Multi-units Luxembourg - Lyxor Daily** ETF price gained **0.433%** on the last trading day (Friday, 28th Jun 2024), rising from **156.94€** to **157.62€**. During the last trading day the ETF fluctuated **1.31%** from a day low at **157.26€** to a day high of **159.32€**. The price has risen in 6 of the last 10 days and is up by **2.38%** over the past 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, **10 thousand** more shares were traded than the day before. In total, **16 thousand** shares were bought and sold for approximately **2.56€** million.

The ETF is moving within a wide and horizontal trend and further movements within this trend can be expected. Given the current horizontal trend, you can expect **Multi-units Luxembourg - Lyxor Daily** ETF with a 90% probability to be traded between **155.10€** and **173.20€** at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and ETFs seldom manage to go directly from the bottom of a trend up to the top. ETFs turning up in the middle of a horizontal trend are therefore considered to be potential runners.

A buy signal was issued from a pivot bottom point on **Friday, June 14, 2024**, and so far it has risen 2.38%. Further rise is indicated until a new top pivot has been found. Volume is rising along with the price. This is considered to be a good technical signal. Some negative signals were issued as well, and these may have some influence on the near short-term development. The **Multi-units Luxembourg - Lyxor Daily** ETF holds a buy signal from the short-term Moving Average; at the same time, however, the long-term average holds a general sell signal. Since the long-term average is above the short-term average there is a general sell signal in the ETF giving a more negative forecast for the stock. On further gains, the ETF will meet resistance from the long-term Moving Average at **162.37€**. On a fall, the ETF will find some support from the short-term average at **157.28€**. A break-up through the long-term average will give another buy signal, while a fall below the short-term average will add another sell signal and strengthen the general signal. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD).

Multi-units Luxembourg - Lyxor Daily finds support from accumulated volume at **154.92€** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the ETF meets some resistance just above today's level from accumulated volume at **158.30€**, **162.94€** and **163.80€**.

This ETF is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the ETF moved **2.06€ (1.31%)** between high and low. For the last week, the ETF has had daily average volatility of **1.72%**.

Several short-term signals are positive and we conclude that the current level may hold a buying opportunity, as there is a fair chance for **Multi-units Luxembourg - Lyxor Daily** ETF to perform well in the short-term period. We have upgraded our analysis conclusion for this ETF since the last evaluation from a Hold/Accumulate to a Buy candidate.
