Tech commentaries:

The Micromobility.com Inc. stock price fell by -7.69% on the last day (Tuesday, 25th Jun 2024) from \$0.0130 to \$0.0120. During the last trading day the stock fluctuated 12.15% from a day low at \$0.0107 to a day high of \$0.0120. The price has fallen in 5 of the last 10 days and is down by -18.92% for this period. Volume has increased on the last day by 15 thousand shares but on falling prices. This may be an early warning and the risk will be increased slightly over the next couple of days. In total, 42 thousand shares were bought and sold for approximately \$505.85.

The stock lies in the lower part of a very wide and strong rising trend in the short term, and this may normally pose a very good buying opportunity. If the lower trend floor at \$0.0111 is broken, it will firstly indicate a slower rate of rising, but may also be an early warning for a trend shift. Given the current short-term trend, the stock is expected to rise 86.72% during the next 3 months and, with a 90% probability hold a price between \$0.0207 and \$0.0382 at the end of this 3-month period.

There are few to no technical positive signals at the moment. The Micromobility.com Inc. stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at \$0.0125 and \$0.0136. A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on Friday, May 24, 2024, and so far it has fallen -31.03%. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD). Micromobility.com Inc. gained volume on the last day, but on falling prices. In technical terms, this is called divergence and may be an early warning. In some cases, increasing volume on falling prices may be considered positive, but that is mainly in typical "sell-offs". The very low volume increases the risk and reduces the other technical signals issued.

Micromobility.com Inc. finds support from accumulated volume at \$0.0116 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance from accumulated volume at \$0.0133, \$0.0145 and \$0.0148.

This stock may move very much during the day (volatility) and with a very large prediction interval from the Bollinger Band this stock is considered to be "very high risk". During the last day, the stock moved \$0.0013 between high and low, or 12.15%. For the last week, the stock has had daily average volatility of 21.30%.

The Micromobility.com Inc. stock holds several negative signals and despite the positive trend, we believe Micromobility.com Inc. will perform weakly in the next couple of days or weeks. Therefore, we hold a negative evaluation of this stock.
