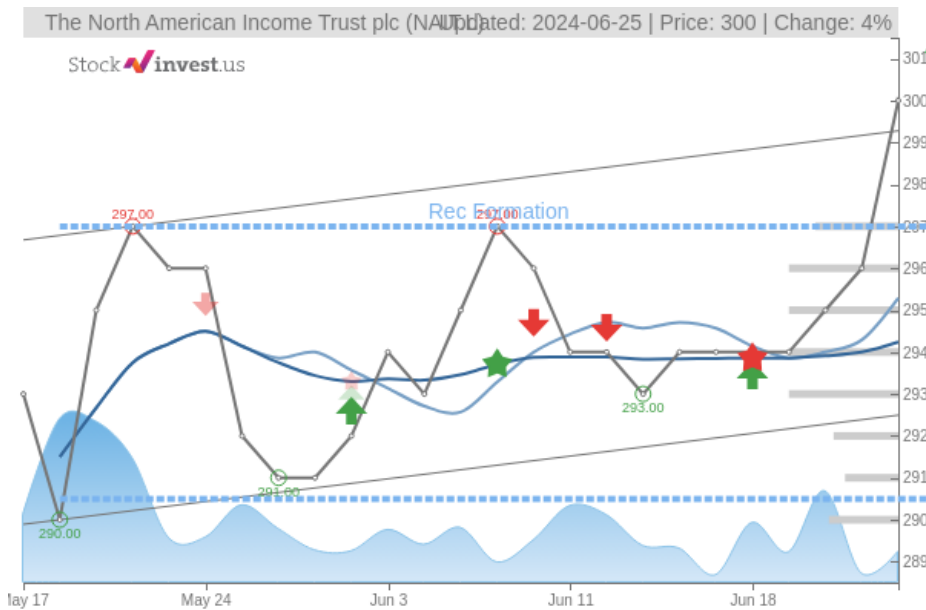

Tech commentaries:

The **The North American Income Trust plc** trust price gained **1.35%** on the last trading day (Tuesday, 25th Jun 2024), rising from **£296.00** to **£300.00**. It has now gained 3 days in a row. It will be exciting to see whether it manages to continue gaining or take a minor break for the next few days. During the last trading day the trust fluctuated **1.69%** from a day low at **£295.00** to a day high of **£300.00**. The price has risen in 4 of the last 10 days and is up by **1.35%** over the past 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, **59 thousand** more shares were traded than the day before. In total, **205 thousand** shares were bought and sold for approximately **£61.57 million**.

The trust has broken the narrow and horizontal trend up. Breaks like this are often followed by swift and strong movements, and any correction down to the breakline at approximately **£299.28** is considered to be a "second chance" to hit a potential runner. It is, however, important that volume does follow the price as false breaks may appear and it may move back into the horizontal trend. Based on the rectangle-formation theory the trust is predicted to reach **£306.06** sometime during the next 3 months.

The **The North American Income Trust plc** trust holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **£295.29** and **£294.24**. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on **Thursday, June 13, 2024**, and so far it has risen 2.39%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume is rising along with the price. This is considered to be a good technical signal.

The North American Income Trust plc finds support from accumulated volume at £296.00 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. There is no resistance from accumulated volume above today's level and given the right condition the trust may perform very well during the next couple of days.

In general the trust tends to have very controlled movements and with good liquidity the risk is considered very low in this stock. During the last day, the trust moved **£5.00** between high and low, or **1.69%**. For the last week the trust has had daily average volatility of **1.31%**.

The North American Income Trust plc holds several positive signals, but we still don't find these to be enough for a buy candidate. At the current level, it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development. Due to some small weaknesses in the technical picture we have downgraded our analysis conclusion for this trust since the last evaluation from a Buy to a Hold/Accumulate candidate.
