

## Tech commentaries:

The Nextleaf Solutions Ltd. stock price gained 0.85\% on the last trading day (Friday, 17th May 2024), rising from $\mathbf{\$ 0 . 1 0 6}$ to $\$ 0.107$. During the last trading day the stock fluctuated $\mathbf{4 . 6 2 \%}$ from a day low at $\$ 0.106$ to a day high of $\$ 0.111$. The price has been going up and down for this period, and there has been a $3.08 \%$ gain for the last 2 weeks. Volume has increased on the last day along with the price, which is a positive technical sign, and, in total, 59 thousand more shares were traded than the day before. In total, $\mathbf{7 4}$ thousand shares were bought and sold for approximately $\$ 7.94$ thousand.

The stock lies in the middle of a very wide and falling trend in the short term and further fall within the trend is signaled. Given the current short-term trend, the stock is expected to fall $-8.58 \%$ during the next 3 months and, with a $90 \%$ probability hold a price between $\$ 0.0702$ and $\$ 0.119$ at the end of this 3 -month period.

The Nextleaf Solutions Ltd. stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at $\mathbf{\$ 0 . 1 0 1}$ and $\$ 0.0994$. A breakdown below any of these levels will issue sell signals. Nextleaf Solutions Ltd. has increased volume and follows the last lift in the price. This is considered to be a technical positive sign as volume should follow the price-formation. The very low volume increases the risk and reduces the other technical signals issued. Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on Friday, April 26, 2024, and so far it has fallen $-3.34 \%$. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD).

On the downside, the stock finds support just below today's level from accumulated volume at $\$ 0.0960$ and $\$ 0.0900$. On the upside the stock meets some resistance from accumulated volume at $\$ 0.112, \$ 0.114$ and $\$ 0.124$.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved $\$ 0.0049$ between high and low, or $\mathbf{4 . 6 2 \%}$. For the last week, the stock has had daily average volatility of $\mathbf{1 8 . 4 3 \%}$.

Several short-term signals are positive, despite the stock being in a falling trend, we conclude that the current level may hold a buying opportunity as there is a fair chance for stock to perform well in the short-term. We have upgraded our analysis conclusion for this stock since the last evaluation from a Hold/Accumulate to a Buy candidate.
