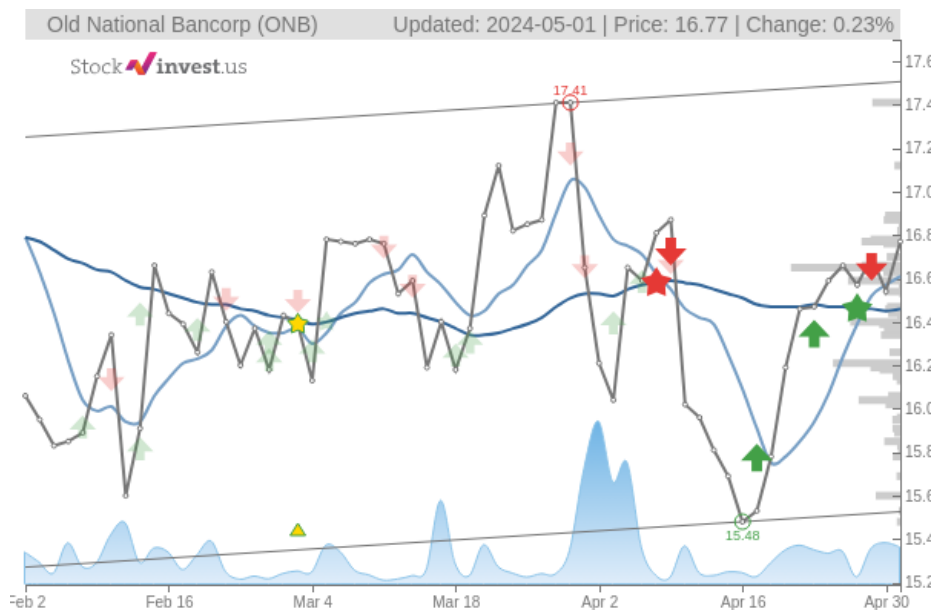


# Old National Bancorp (Wed, May 01, 2024)

## Tech commentaries:

The **Old National Bancorp** stock price gained **1.39%** on the last trading day (Wednesday, 1st May 2024), rising from **\$16.54** to **\$16.77**. During the last trading day the stock fluctuated **3.14%** from a day low at **\$16.56** to a day high of **\$17.08**. The price has risen in 8 of the last 10 days and is up by **7.98%** over the past 2 weeks. Volume fell on the last day by **-171 thousand** shares and in total, **2 million** shares were bought and sold for approximately **\$40.83** million. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock is moving within a wide and horizontal trend and further movements within this trend can be expected. Given the current horizontal trend, you can expect **Old National Bancorp** stock with a 90% probability to be traded between **\$15.76** and **\$17.77** at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and stocks seldom manage to go directly from the bottom of a trend up to the top. Stocks turning up in the middle of a horizontal trend are therefore considered to be potential runners.

Mostly positive signals in the chart today. The **Old National Bancorp** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **\$16.61** and **\$16.46**. A breakdown below any of these levels will issue sell signals. A buy signal was issued from a pivot bottom point on **Tuesday, April 16, 2024**, and so far it has risen 8.33%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely.

**Old National Bancorp** finds support from accumulated volume at **\$16.65** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **\$16.78**, **\$16.87** and **\$17.41**.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved **\$0.520** between high and low, or **3.14%**. For the last week, the stock has had daily average volatility of **2.03%**.

Several short-term signals are positive and we conclude that the current level may hold a buying opportunity, as there is a fair chance for **Old National Bancorp** stock to perform well in the short-term period. We have upgraded our analysis conclusion for this stock since the last evaluation from a Hold/Accumulate to a Buy candidate.
