

## **Tech commentaries:**

The Shilchar Technologies Limited stock price fell by -2.82% on the last day (Friday, 17th May 2024) from ?5,463.90 to ?5,309.70. During the last trading day the stock fluctuated 8.75% from a day low at ?5,190.75 to a day high of ?5,645.00. The price has fallen in 7 of the last 10 days and is down by -8.95% for this period. Volume fell on the last day along with the stock, which is actually a good sign as volume should follow the stock. On the last day, the trading volume fell by -4 thousand shares and in total, 11 thousand shares were bought and sold for approximately ?60.47 million.

The stock lies in the lower part of a very wide and strong rising trend in the short term, and this may normally pose a very good buying opportunity. If the lower trend floor at ?5,084.85 is broken, it will firstly indicate a slower rate of rising, but may also be an early warning for a trend shift. Given the current short-term trend, the stock is expected to rise 48.76% during the next 3 months and, with a 90% probability hold a price between ?7,564.41 and ?10,324.88 at the end of this 3-month period.

The Shilchar Technologies Limited stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at ?5,271.94 and ?5,177.43. A breakdown below any of these levels will issue sell signals. Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on Tuesday, April 30, 2024, and so far it has fallen -17.83%. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell together with the price during the last trading day and this reduces the overall risk as volume should follow the price movements.

Shilchar Technologies Limited finds support from accumulated volume at ?5,115.05 and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at ?5,461.00, ?5,541.90 and ?5,569.35.

This stock may move much during the day (volatility) and with a large prediction interval from the Bollinger Band this stock is considered to be "high risk". During the last day, the stock moved ?454.25 between high and low, or 8.75%. For the last week, the stock has had daily average volatility of 6.72%.

Several short-term signals, along with a general good trend, are positive and we conclude that the current level may hold a buying opportunity as there is a fair chance for Shilchar Technologies Limited stock to perform well in the short-term.
