

## **Tech commentaries:**

The Siemens Healthineers AG stock price fell by -0.371% on the last day (Tuesday, 2nd Jul 2024) from 53.84€to 53.64€ During the last trading day the stock fluctuated 0.94% from a day low at 53.30€to a day high of 53.80€ The price has risen in 6 of the last 10 days and is up by 2.29% over the past 2 weeks. Volume fell on the last day along with the stock, which is actually a good sign as volume should follow the stock. On the last day, the trading volume fell by -164 thousand shares and in total, 420 thousand shares were bought and sold for approximately 22.52€ million.

The stock is moving within a horizontal trend and further movements within this trend can be expected. Given the current horizontal trend, you can expect **Siemens Healthineers AG** stock with a 90% probability to be traded between 51.85€ and 56.00€ at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and stocks seldom manage to go directly from the bottom of a trend up to the top. Stocks turning up in the middle of a horizontal trend are therefore considered to be potential runners.

There are few to no technical positive signals at the moment. The Siemens Healthineers AG stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. On corrections up, there will be some resistance from the lines at 54.02€ and 53.79€ A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on Thursday, June 27, 2024, and so far it has fallen -3.11%. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell together with the price during the last trading day and this reduces the overall risk as volume should follow the price movements.

Siemens Healthineers AG finds support from accumulated volume at 53.02€ and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at 53.70€ 53.80€ and 55.36€

In general the stock tends to have very controlled movements and with good liquidity the risk is considered very low in this stock. During the last day, the stock moved 0.500€ between high and low, or 0.94%. For the last week the stock has had daily average volatility of 1.81%.

Siemens Healthineers AG holds several negative signals and is within a falling trend, so we believe it will still perform weakly in the next couple of days or weeks. We therefore hold a negative evaluation of this stock. Due to some small weaknesses in the technical picture we have downgraded our analysis conclusion for this stock since the last evaluation from a Hold/Accumulate to a Sell candidate.
