Tech commentaries:

No changes to the price of **Straight Path Communications Inc** fund on the last trading day (Wednesday, 7th Mar 2018). During the last trading day the fund fluctuated **0%** from a day low at **\$183.37** to a day high of **\$183.37**. The price has been going up and down for this period, and there has been a 0.46% gain for the last 2 weeks.

The fund is moving within a narrow and horizontal trend and further movements within this trend can be expected. Given the current horizontal trend, you can expect **Straight Path Communications Inc** fund with a 90% probability to be traded between **\$184.39** and **\$188.91** at the end of this 3-month period. A break of a horizontal trend is often followed by a large increase in the volume, and funds seldom manage to go directly from the bottom of a trend up to the top. Funds turning up in the middle of a horizontal trend are therefore considered to be potential runners.

The **Straight Path Communications Inc** fund holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **\$183.37** and **\$183.14**. A breakdown below any of these levels will issue sell signals. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on **Monday, February 26, 2018**, and so far it has fallen -1.35%. Further fall is indicated until a new bottom pivot has been found. Volume fell on the last day without any changes to the price. This does not cause any direct divergence but may be an early warning and a possible "turning point". The very low volume increases the risk and reduces the other technical signals issued.

Straight Path Communications Inc finds support from accumulated volume at **\$183.00** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the fund meets some resistance just above today's level from accumulated volume at **\$183.85**, **\$185.84** and **\$185.87**.

In general the fund tends to have very controlled movements and therefore the general risk is considered very low. However, be aware of low or falling volume and make sure to keep an eye on the fund During the last day, the fund moved **\$0** between high and low, or **0%**. For the last week the fund has had daily average volatility of **0%**

Several short-term signals are positive and we conclude that the current level may hold a buying opportunity, as there is a fair chance for **Straight Path Communications Inc** fund to perform well in the short-term period.
