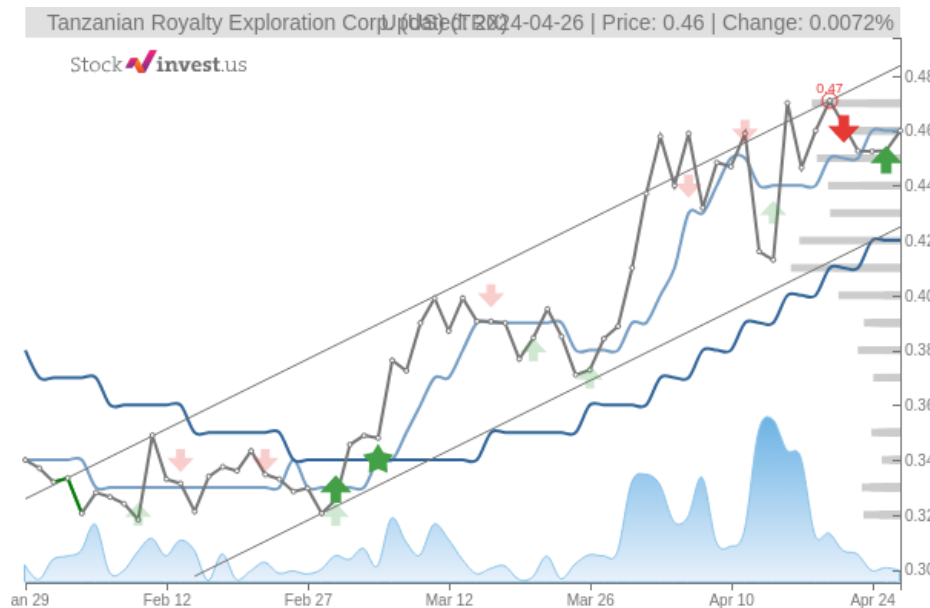


# Tanzanian Royalty Exploration Corp. (US) (Fri, Apr 26, 2024)

## Tech commentaries:

The **Tanzanian Royalty Exploration Corp. (US)** stock price gained **1.59%** on the last trading day (Friday, 26th Apr 2024), rising from **\$0.453 to \$0.460**. During the last trading day the stock fluctuated **2.34%** from a day low at **\$0.453** to a day high of **\$0.464**. The price has been going up and down for this period, and there has been a **10.58%** gain for the last 2 weeks. Volume fell on the last day by **-17 thousand** shares and in total, **161** thousand shares were bought and sold for approximately **\$73.99** thousand. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock lies in the middle of a wide and strong rising trend in the short term and a further rise within the trend is signaled. Given the current short-term trend, the stock is expected to rise **48.46%** during the next 3 months and, with a 90% probability hold a price between **\$0.631** and **\$0.718** at the end of this 3-month period.

There are mixed signals in the stock today. A sell signal was issued from a pivot top point on **Friday, April 19, 2024**, and so far it has fallen **-2.34%**. Further fall is indicated until a new bottom pivot has been found. Furthermore, there is currently a sell signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day while the price increased. This causes a divergence and may be considered as an early warning, but it may not be. The very low volume increases the risk and reduces the other technical signals issued. The **Tanzanian Royalty Exploration Corp. (US)** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **\$0.459** and **\$0.421**. A breakdown below any of these levels will issue sell signals.

**Tanzanian Royalty Exploration Corp. (US)** finds support from accumulated volume at **\$0.447** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **\$0.462**, **\$0.470** and **\$0.471**.

This stock has average movements during the day, but be aware of low or falling volume as this increases the risk. During the last day, the stock moved **\$0.0106** between high and low, or **2.34%**. For the last week the stock has had daily average volatility of **2.45%**.

Several short-term signals, along with a general good trend, are positive and we conclude that the current level may hold a buying opportunity as there is a fair chance for **Tanzanian Royalty Exploration Corp. (US)** stock to perform well in the short-term. We have upgraded our analysis conclusion for this stock since the last evaluation from a Hold/Accumulate to a Buy candidate.
