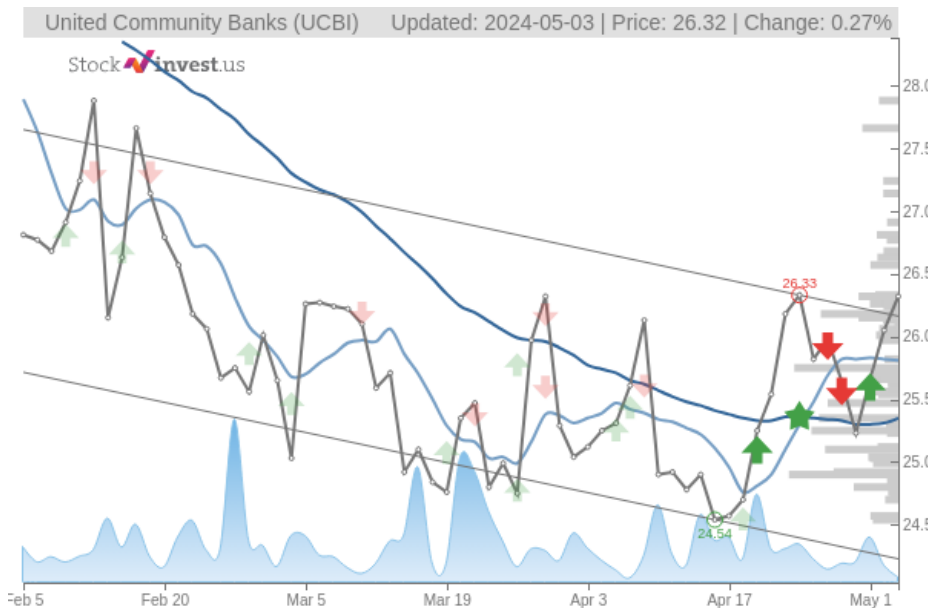

Tech commentaries:

The **United Community Banks** stock price gained **1.04%** on the last trading day (Friday, 3rd May 2024), rising from **\$26.05** to **\$26.32**. It has now gained 3 days in a row. It will be exciting to see whether it manages to continue gaining or take a minor break for the next few days. During the last trading day the stock fluctuated **1.99%** from a day low at **\$26.15** to a day high of **\$26.67**. The price has risen in 7 of the last 10 days and is up by **4.24%** over the past 2 weeks. Volume fell on the last day by **-107 thousand** shares and in total, **285** thousand shares were bought and sold for approximately **\$7.50** million. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock has broken the falling short-term trend up. Firstly a slower falling rate is indicated, but this may very well be an early signal of a trend shift. On the reaction, there will be support on the roof of the current trend broken, which is **\$26.16**, a level that may pose a second chance to hit a runner. According to fan-theory **\$28.10** will be the next possible trend-top level and thereby pose a resistance level that may not be broken at the first attempt.

The **United Community Banks** stock holds buy signals from both short and long-term Moving Averages giving a positive forecast for the stock. Also, there is a general buy signal from the relation between the two signals where the short-term average is above the long-term average. On corrections down, there will be some support from the lines at **\$25.81** and **\$25.35**. A breakdown below any of these levels will issue sell signals. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely. Some negative signals were issued as well, and these may have some influence on the near short-term development. A sell signal was issued from a pivot top point on **Wednesday, April 24, 2024**, and so far it has fallen -0.0380%. Further fall is indicated until a new bottom pivot has been found.

United Community Banks finds support from accumulated volume at **\$25.75** and this level may hold a buying opportunity as an upwards reaction can be expected when the support is being tested. On the upside the stock meets some resistance just above today's level from accumulated volume at **\$26.33**, **\$26.57** and **\$27.66**.

This stock is usually traded at a good volume, and with minor daily changes, the risk is considered to be low. During the last day, the stock moved **\$0.520 (1.99%)** between high and low. For the last week, the stock has had daily average volatility of **1.99%**.

United Community Banks holds several positive signals, but we still don't find these to be enough for a buy candidate. At the current level, it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development.
