## **Tech commentaries:**

The vTv Therapeutics Inc. stock price fell by -15.24% on the last day (Thursday, 2nd May 2024) from \$27.96 to \$23.70. During the last trading day the stock fluctuated 26.85% from a day low at \$22.87 to a day high of \$29.01. The price has risen in 7 of the last 10 days but is still down by -4.2% for this period. Volume has increased on the last day by 20 thousand shares but on falling prices. This may be an early warning and the risk will be increased slightly over the next couple of days. In total, 24 thousand shares were bought and sold for approximately \$573.49 thousand.

Given the current short-term trend, the stock is expected to rise **119.82%** during the next 3 months and, with a 90% probability hold a price between **\$52.10** and **\$86.04** at the end of this 3-month period.

Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Some negative signals were issued as well, and these may have some influence on the near short-term development. The **vTv Therapeutics Inc.** stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. On corrections up, there will be some resistance from the lines at **\$26.57** and **\$24.41**. A break-up above any of these levels will issue buy signals. A sell signal was issued from a pivot top point on **Thursday, March 21, 2024**, and so far it has fallen -18.28%. Further fall is indicated until a new bottom pivot has been found. **vTv Therapeutics Inc.** gained volume on the last day, but on falling prices. In technical terms, this is called divergence and may be an early warning. In some cases, increasing volume on falling prices may be considered positive, but that is mainly in typical "sell-offs".

On the downside, the stock finds support just below today's level from accumulated volume at **\$21.59** and **\$21.23**. On the upside the stock meets some resistance just above today's level from accumulated volume at **\$23.80**, **\$26.67** and **\$29.00**.

This stock has average movements during the day and with good trading volume, the risk is considered to be medium. During the last day, the stock moved **\$6.14** between high and low, or **26.85%**. For the last week, the stock has had daily average volatility of **10.85%**.

The vTv Therapeutics Inc. stock holds several negative signals and despite the positive trend, we believe vTv Therapeutics Inc. will perform weakly in the next couple of days or weeks. Therefore, we hold a negative evaluation of this stock. Due to some small weaknesses in the technical picture we have downgraded our analysis conclusion for this stock since the last evaluation from a Buy to a Sell candidate.
