

Tech commentaries:

The **Wolfspeed, Inc.** stock price gained **2.41%** on the last trading day (Monday, 6th May 2024), rising from **\$25.33** to **\$25.94**. During the last trading day the stock fluctuated **4.37%** from a day low at **\$25.18** to a day high of **\$26.28**. The price has risen in 6 of the last 10 days and is up by **8.35%** over the past 2 weeks. Volume fell on the last day by **-2 million** shares and in total, **4 million** shares were bought and sold for approximately **\$95.62 million**. You should take into consideration that falling volume on higher prices causes divergence and may be an early warning about possible changes over the next couple of days.

The stock lies in the middle of a very wide and falling trend in the short term and further fall within the trend is signaled. Given the current short-term trend, the stock is expected to fall **-6.86%** during the next 3 months and, with a 90% probability hold a price between **\$20.30** and **\$27.03** at the end of this 3-month period.

A buy signal was issued from a pivot bottom point on **Thursday, May 02, 2024**, and so far it has risen 10.10%. Further rise is indicated until a new top pivot has been found. Furthermore, there is a buy signal from the 3 month Moving Average Convergence Divergence (MACD). Volume fell during the last trading day despite gaining prices. This causes a divergence between volume and price and it may be an early warning. The stock should be watched closely. Some negative signals were issued as well, and these may have some influence on the near short-term development. The **Wolfspeed, Inc.** stock holds sell signals from both short and long-term Moving Averages giving a more negative forecast for the stock. Also, there is a general sell signal from the relation between the two signals where the long-term average is above the short-term average. On corrections up, there will be some resistance from the lines at **\$26.01** and **\$26.29**. A break-up above any of these levels will issue buy signals.

On the downside, the stock finds support just below today's level from accumulated volume at **\$23.94** and **\$23.56**. On the upside the stock meets some resistance just above today's level from accumulated volume at **\$26.25**, **\$27.98** and **\$28.43**.

This stock may move much during the day (volatility) and with a large prediction interval from the Bollinger Band this stock is considered to be "high risk". During the last day, the stock moved **\$1.10** between high and low, or **4.37%**. For the last week, the stock has had daily average volatility of **7.68%**.

Wolfspeed, Inc. holds several negative signals and this should be a sell candidate, but due to the general chance for a turnaround situation it should be considered as a hold candidate (hold or accumulate) in this position whilst awaiting further development. We have upgraded our analysis conclusion for this stock since the last evaluation from a Sell to a Hold/Accumulate candidate.
